Chronic Cardiac Wellness

Cardiovascular disease (CVD) remains the leading cause of morbidity and mortality worldwide.¹ Despite significant advances in treatment, chronic cardiac conditions continue to place an immense burden on healthcare systems. Frontline healthcare providers play a crucial role in promoting cardiac wellness, not only through acute care interventions but also through preventive and chronic disease management strategies.

Role of Physicians in Promoting Cardiac Wellness

- Early Detection and Risk Assessment: Routine screening for hypertension, dyslipidemia and diabetes is essential.
- Medication Adherence: Ensure members understand the importance of adherence to prescribed therapies, including antihypertensives, statins and antiplatelet agents.
- Patient Education and Lifestyle Counseling: Encourage members to adopt heart-healthy habits, such as the Mediterranean diet, regular physical activity and smoking cessation.²
 - Members can participate in our <u>Care Management</u>
 <u>program</u>. The Care Management program assists in coordinating members with medical or social complex needs to optimize health and prevent disease.
 - Members can earn <u>My Health Pays</u> rewards by completing healthy activities.

Importance of Chronic Cardiac Wellness

Cardiovascular conditions, such as hypertension, coronary artery disease and heart failure, can be effectively managed with lifestyle modifications, pharmacologic therapy and regular monitoring. By prioritizing early intervention, preventive care and patient-centered approaches, physicians can make an impact on the long-term health of patients and the overall burden on healthcare systems.

Enhanced Language Services Request Form

Check out our updated member and provider Language Services Request Form!

Key enhancements include:

- A prompt to confirm whether video remote interpreting (VRI) is an option.
- Inclusion of product line information for better service alignment.
- Clarification that ongoing interpreter requests are valid for up to three months. If services are still needed after that period, a new request form must be submitted to avoid any interruption in interpretation services.

Iowa Medicaid Prior Authorization

Effective April 1, 2025, Iowa Medicaid had changes to their prior authorization criteria. Changes apply to the following:

- Dupilumab (Dupixent)
- · Ensifentrine (Ohtuvayre)
- · Incretin mimetics for non-diabetes indications
- · Select preventative migraine treatments
- · Select topical agents
- · Vonoprazan (Voquenza)

Prepare Members for Summer

Summer is approaching fast! Help keep members safe this summer by sharing **the following tips**:

- Keep medications in a cool, dry place.
- Do not store medications in the sun or car. Heat and moisture can break down medications.
- Remind members to use sunscreen, especially if prescribing medications that increase sun sensitivity.
 Inform members of the following:
 - Use sunscreen that offers broad-spectrum protection against both UVA and UVB rays.

- Use sunscreen with a SPF of at least 15, but higher SPF is recommended for extended outdoor activities.
- Apply sunscreen generously and reapply every two hours.
 Apply more often if swimming or sweating.
- Wear sunglasses that block 100% of UVA and UVB rays to protect eyes from sun damage.
- Consider clothing specifically designed to block UV rays.1

Spread the Word

If Iowa Total Care members are pregnant or thinking about becoming pregnant, they should follow these steps:

- Go before they show! Encourage members to go to their doctor as soon as they think they are pregnant. Early and routine care will help and protect them and their baby.
- Complete an Iowa Total Care Notification of Pregnancy (NOP) form online in our member portal.
- Join our <u>Start Smart for Your Baby</u>® program for care and support throughout pregnancy.
- Keep healthy lifestyle habits! This includes exercising, eating healthy meals and resting for 8-10 hours each night.

Iowa Total Care members can earn up to \$60 in My Health Pays® rewards by going to the doctor and completing an NOP form in the first 12 weeks of pregnancy.

Trainings

Iowa Total Care is excited to offer behavioral health, physical health and long-term services and supports trainings for all Iowa providers – at no cost!

Adult Mental Health First Aid (MHFA)

The Adult MHFA course focuses on recognizing the patterns of thoughts, feelings, behaviors and appearance that show there might be a challenge rather than on a specific disorder. Adult MHFA teaches a five-step action plan to help people who might be experiencing a mental health crisis.

By the end of the training, providers will be able to:

- Identify common signs and symptoms of mental health and substance use challenges.
- Understand how to interact with a person in crisis and connect them with help.
- Understand the expanded content on trauma, substance use and self-care.

Session Information

These courses use MHFA Connect and Zoom. Once you register, you will receive a link to join MHFA Connect. You must create an account in MHFA Connect to complete the self-paced introduction. You will not be able to attend the virtual instructor-led portion unless you complete the self-paced introduction.

Appeal - Laws and Policies

Iowa Total Care utilizes a hierarchy when determining the most appropriate law or policy to reference while conducting an appeal investigation. As a reminder, federal guidelines establish the foundational requirements for Medicaid programs. Each state uses their own clinical policies within the federal framework, including which services require prior authorization and the criteria for approval. Iowa Total Care is responsible for implementing the policies in accordance with the rules and standards set by the Iowa Department of Health and Human Services.


Policy Review

Avoid Claim Rejections - Ensure Your Taxonomy Code is Accurate

To help ensure timely claims payment and minimize rejections, it's critical to include a valid taxonomy code when submitting a claim. Since Ambetter launched in Iowa on January 1, 2025, 23.1% of claim rejections have been due to Reject 91: Invalid or Missing Taxonomy Code. We want to help reduce this issue and keep your claims moving smoothly.

What is a taxonomy code?

A taxonomy code is a 10-digit code established at the federal level that identifies a provider's unique specialty or area of expertise.

Where can I find my taxonomy code?

You can locate your taxonomy code using the National Uniform Claim Committee (NUCC) code set list.

Why does it matter?

Using the correct taxonomy code ensures:

- · Accurate identification of your specialty
- · Correct contract pricing
- Compliance with claims processing standards
- · Timely and accurate reimbursement
