

# Help Keep Colon Cancer at Bay

As colorectal (colon) cancer is the third leading cause of cancer death in the United States, it's important to ensure members get a colorectal cancer screening. The Centers for Disease Control and Prevention and the U.S. Preventive Services Task Force recommend that everyone 45 to 75 years old get a colorectal cancer screening.

Those with a family history of the disease or with other conditions that could lead to colorectal cancer may need to get screened earlier. Early detection is vital, especially for the African American population, as African Americans have a higher risk of death from colorectal cancer than any other racial or ethnic group in the US.





#### **Iowa Total Care Cultural Competency**

Practicing cultural and linguistic competency allows us to provide respectful and responsive care to patients with diverse values, beliefs and behaviors, including tailoring healthcare delivery to meet patients' social, cultural and linguistic needs.

Better cross-cultural and linguistic communications can play a role in reducing health disparities prevalent throughout Iowa. Iowa Total Care estimates that our membership represents **over 140 spoken languages and cultures** with 7.65% of the Iowa Total Care population identifying as speaking a non-English language. The most common non-English language is Spanish, which is spoken by 3.9% of the Iowa population.

#### **Supporting Workforce Retention**

As part of Iowa Total Care's commitment to our providers and workforce retention, three organizations in our network were awarded mini grants of **\$15,000** each.

# Two New Explanation of Payment (EOP) Codes

The EOP now includes these EX codes to help ease the identification of reconsideration decisions:

- EXh7: The reconsideration decision is overturned.
   Providers will receive this code if there is a payment on the EOP.
- EXhA: The reconsideration decision is upheld.
   Providers will receive this code if the reconsideration decision is upheld and thus no payment is reflected.

#### **Provider Tip: Downcoding**

In response to provider outreach to our Provider Relations Specialists, Iowa Total Care wants to remind providers of a payment policy related to Evaluation and Management (E&M) Overcoding.

The E&M Overcoding policy was put in place by our Coding & Analytics team on March 3, 2021. This is a pre-payment edit on E&M claims that reviews the code billed in relation to the diagnostic codes also used on the claim. Pre-payment decisions can be overturned if/when providers file a claim dispute submitting medical documentation to support the level of E&M code they billed.

Routine analysis by an internal Iowa Total Care team will modify those edits for a particular provider if needed. Providers that disagree with denials or downcoding can dispute and attach the medical documentation to support that billing.

## Limited Doula Services Currently Available for African American/ Black Identifying Individuals
