Mental Health Awareness Month

May is Mental Health Awareness Month, and it's important we provide behavioral health support to those we serve. Iowa Total Care offers an online tool for our adult members called **myStrength**, which can be found on our [website](#). This tool can help members build emotional strength, find inspiration and stories of hope, receive support for their mind/body/spirit and track their progress along the way.

Mental health services are also available for Iowa Total Care members via the **Babylon app**. Prescribing Antipsychotic Medications

Antipsychotic medications are effective in treating symptoms of certain mental health illnesses such as schizophrenia and bipolar disorder, in addition to a range of emotional problems.

Despite benefits for many, antipsychotics may have significant side effects such as:

- Considerable weight gain and obesity-related complications
- Diabetes
- Cardiovascular issues such as hypertension
- Hypercholesterolemia
- Movement disorders

It's important to perform a metabolic baseline test and ongoing annual testing for all patients (children through adults) who take antipsychotic medications.

Ensure all patients prescribed antipsychotic medications have the appropriate metabolic testing.

** CPT Codes HbA1c Test: 83036, 83037 Glucose Test: 80047, 80048, 80050, 80053, 80069, 82947, 82950, 82951 LDL-C (Cholesterol) Test: 80061, 83700, 83701, 83704, 83721 **

(The HEDIS measure for Metabolic Monitoring for children requires both LDL-C and HbA1c/Glucose testing.)

Before prescribing:

- Conduct a thorough physical exam of your patient.
- Ensure patients have been appropriately evaluated and diagnosed.
- Collaborate with and refer patients to mental health professionals.
- If intended as short-term intervention, note the Stop Date and schedule the follow-up.



- Educate patients about possible side effects that must be monitored with regular blood tests.
- Tell patients why it's important to keep appointments with all treating providers.

Next steps—talk with your patient about:

- How to take the medication
- How they work
- Medication benefits
- How long the patient should take them and why it's important to keep taking medication even if the patient begins feeling better

PRESCRIPTION DRUG LIST CHANGES



In November, Iowa Medicaid published [Informational Letter 2291](#), which moved Vyvanse from “preferred” to “non-preferred, and Clinical PA criteria apply” as shown on page 3 of that letter. The Clinical Prior Authorization criteria can be found on the [Iowa Medicaid Preferred Drug website](#).

Additionally, there are alternative medicines that can be utilized. For anyone in the age group 6–20, dextroamphetamine sulfate ER and amphetamine-dextroamphetamine ER are long-acting medications in the amphetamine family that do not require a prior authorization.

There are also several long-acting medications in the methylphenidate family that **do not** require a prior authorization for this age group. For adult patients, any previously approved and in-date prior authorization for Vyvanse continues to be honored.



Prior Authorization for Drugs


As of **July 1, 2022**, medical benefit prior authorizations for drugs are required to be determined by the next business day from the request date. Additional information will be requested within 24 hours of receipt of prior authorization request. We are bringing this to your attention because this may impact prior authorizations submitted later in the day on Fridays.
